#### BUYER'S RIGHTS

You may cancel this agreement at any time within three (3) business days of the date of this agreement, without further obligation or penalty. Notice of cancellation must be submitted in writing to Bodifi via registered or certified mail.

At any point thereafter, this agreement may be cancelled **only under the following circumstances:** 

- 1. If you become totally disabled, as defined by legal and medical standards in the state of Idaho. You must provide written documentation from a medical doctor of such diagnosis, and submit a request for cancellation in writing.
- 2. In the event of the death of the member designated on the face of this agreement, then the estate of said member shall have the right to request cancellation of said membership.
- 3. If you relocate more than thirty-five (35) miles away from Bodifi. You must provide written documentation of said relocation, in the form of utility bills, recent mail, etc, as well as submit a request for cancellation in writing and you must provide thirty (30) days written notice of cancellation and pay \$58.00 (VIP) or any applicable cancellation or buy out fee.
